



CLONCURRY SHOW CAMPOVEN COOK-OFF RULES

GENERAL RULES & REGULATIONS

Entry Fee: \$10 [MUST BE OVER 18 TO PARTICIPATE]

Prize: 1st 2nd 3rd

1. All nominations must be in writing and accompanied by full payment of nomination fee to secure nomination. No verbal nominations will be accepted.

3. Nominations must be received no later than 5pm on 12 June 2019. Late nominations may be accepted at the discretion of the Judges. Depending upon circumstances, at the discretion of the Judges, a maximum of 15 nominations will be accepted.

All entries are to be cooked on site at the Cloncurry Show Grounds at the Cattle section. Judging includes presentation, taste and cleanliness. Cleanliness in all areas must be observed at all times.

Firewood will be supplied for cooking purposes only. It is acceptable to bring your own.

4. Competitors are to prepare their best camp oven meal to be served on a plate for judging (e.g. stew, roast, damper) of choice. Wet dish may be cooked with bones, however, they must be removed before presentation for judging.

5. All ingredients and cooking equipment is to be supplied by competitor.

6. All ingredients are to be prepared onsite at allotted stations. BYO table or bench.

Ingredients will be presented to stewards before cooking commences. (If in doubt ask prior to event). Competitors who are using any ingredient which is of a wild source (kangaroo, rabbit, fish or other bush tucker) must ensure it is fit for human consumption as per the Australian Food Safe Rules and Regulations.

Competitors are not to use any modern cooking aids and appliances, including but not limited to: laser thermometers, food processors, Mixmaster's etc...

8. Herbs can be either fresh or bottled.

9. Competitors will present to their station between 11am – 5pm.

10. Event to commence from 12pm, at which time all ingredients should have been viewed by steward.

11. Dish is to be ready for serving at 5.30pm. Further details to be provided at commencement of competition.

13. Each competitor will be permitted to have 1 support person only.

14. Anyone entering and their support person entering this competition does so entirely at their own risk. Everyone connected therewith shall have no liability whatsoever for any injury to person, or loss of or damage to property howsoever caused. Organisers will have final say in all matters of safety. Competitors are to ensure the safety of nominated team members within their cooking site at all times. Enclosed foot wear to be worn in cooking area. Thongs and sandals are not acceptable at any time whilst in the cooking area. Failure to adhere to this rule may mean loss of points or disqualification & removal from area.
